OFFICE ORDER

In pursuance of the Headquarters' Office Circular No.21-Staff Wing/2019, circulated vide letter No. 571-Staff (Appt.)/PC Cell/02-2017 dated 14th May, 2019, the Accountant General has been pleased to grant non-functional upgradation (NFU) in Pay Level 9 of Pay Matrix to the Divisional Accounts Officers, on completion of 4 years of regular service in the cadre, from the date of joining as Divisional Accounts Officer Grade-I as per the Annexure hereto, from the date shown against each, subject to the following conditions:

- (i) The benefit of pay fixation admissible as per Rule 13 of CCS Revised Pay Rules, 2016 will be available at the time of grant of non-functional upgradation.
- (ii) NFU granted to the officials will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACPS, if any, is to be reckoned from the date of grant of NFU.

Due to re-fixation of pay, subsequent to grant of NFU, arrears of pay and allowances may be paid to the officials, as admissible under 7th CPC.




